1. The lottery will take place online. The lotteries will be quarterly and the location will be 92 Charlotte Street, Port Colborne, ON, L3K 3E1.

Draw 2 takes place April 1, 2025 – May 16, 2025 and has an Early Bird prize drawn on April 30, 2025, gift valued at \$500. All ticket sales will start at 12:01am on the first day and stop at 2pm on the last day. The draw will take place at 2pm on the final day of ticket sales.

Draw 3 takes place July 1, 2025 – August 5, 2025 and has Early Bird prizes drawn on July 18, 2025, and August 1, 2025 gifts valued at \$500. All ticket sales will start at 12:01am on the first day and stop at 4pm on the last day. The draw will take place at 4pm on the final day of ticket sales.

2. All tickets will only be sold to people who are 18 years of age or older.

3. Must be in the province of Ontario at the time of purchase.

4. Tickets are \$10, \$20 and \$40.

5. Tickets will be available for purchase online at <u>www.portcares5050.ca</u> by credit card or at Port Cares, 92 Charlotte Street, Port Colborne, ON, L3K 3E1 by cash between 8:30 am – 4:30 pm.

6. Tickets will be sold using electronic raffle system supplied by Raffle Nexxus.

7. After buying, patrons will receive a confirmation e-mailed with their 50/50 registered numbers from a Random Selection System. No specific numbers can be given as numbers are generated randomly.

8. The winning ticket number will be selected by a Random Number Generation (RNG) system from all raffle numbers sold for the draw.

9. The amount of the 50/50 will be updated and can be monitored at <u>www.portcares5050.ca</u>, as well as through Port Cares' social media pages and via radio commercials on 89.1FM and 91.7FM.

10. The winning number will be announced on the website www.portcares5050.ca, on Port Cares' social media (Facebook, Instagram and Twitter) and via radio announcements on 91.7FM and 89.1FM.

11. The winner may claim their prize by contacting Port Cares at: (905) 834-3629, or by email at: 5050draw@portcares.ca. The ticket may then be brought to Port Cares, 92 Charlotte Street, Port Colborne, ON, L3K 3E1 at an agreed upon time for ticket verification. The winner will then be paid by cheque for the amount posted at the event for which they bought their ticket. Winners must have the original winning ticket and no copies. All payments will be made by cheque. 12. The winning ticket holder has 6 months in which to claim their prize from the date of the draw their ticket was purchased for.

13. The winner must provide his/her name, address, and phone number with picture identification for our report sheet.

15. In the event that no winner comes forward, the winning stub will be kept in a safety deposit box and held for 6 months. After that time period has elapsed the prize will be donated to a charity other than Port Cares, with the approval of the Alcohol and Gaming Commission of Ontario (AGCO).

16. The following individuals are not eligible to participate in the 50/50 draws:
